The following is a summary of significant information and activity since my last report. It is broken down according to our strategic goals.

#### **ADVOCACY**

- advocate for dentistry in the commonwealth -

#### Insurance Reform Legislative Initiative

We are on track to present a bill in the upcoming session.

#### **Key Legislative Contact Program**

We still need members to establish relationships with their legislators so they can serve as both a resource and an influencer to legislators. Please work with your component to assist us in compiling a list of key legislative contacts. Dr. Beverly Largent will be reaching out to you and your component leaders to get involved in this important activity. We have tentatively scheduled a training for key contacts on November 3<sup>rd</sup> at 7pm.

#### Medicaid Fees

- It has been reported that Avesis has increased a number of fees on their schedule. I will provide more information when it becomes available.
- I am waiting to hear back from Dr. Heitmeier regarding the potential we discussed of following Louisiana in creating a Full Medicaid Pricing model for dentists in Kentucky.
- Dr. Bobrowski, Dr. Greenwell, Libby Milligan and I took a call from Commissioner Lee. She is interested in knowing if we are interested in creating a program which sounds like the Full Medicaid Pricing proposal from Louisiana. She will be sharing more information with board members at our meeting.

#### Soda Tax

The executive director of the KY Beverage Association contacted me recently. She called because she heard we were promoting a soda tax. She is interested in a conversation with us should we decide to pursue this in the legislature.

#### KDA 2022 Legislative Priorities

As we prepare to move into the next legislative session, we have much to do. Our legislative priorities document states our position on issues impacting organized dentistry. It also focuses our lobbying efforts. If there are any changes, edits, or deletions that need to be made to this document, please let us know.

## Membership Report

For the period ending September 30, 2021, our market share was 49.1% which is 1% below this time last year. There was an decrease of 6 licensed dentists in Kentucky (2,495) compared to last year and we ended this period with 29 less members (1,224) on the books than at this time last year. Of all licensed Kentucky dentists, 36% (897) paid full dues. This is 6.1% more than this time last year. The percentage of dentists in Kentucky receiving discounted dues decreased to 13.5% (-7.3%) and the percentage of non-member dentists increased 50.5% (+2.3%). The new monthly snapshot for September 30, 2021 is included as an attachment.

#### **KDA Annual Meeting**

Our projected revenue for this event was \$90K. At this time, it appears the meeting made about \$80K in revenue.

Attendance was somewhat down compared to 2019: 297 Member Dentists (-5); 6 Non-Member Dentists (-9); 170 Hygienists (-35); 37 Office Staff (-15).

Our rock star keynote presenter was a hit and our combining of several standalone events with our keynote and awards reception resulted in lower costs and bigger crowds. I am pleased to report that we also met our room block and food & beverage minimum for the hotel.

#### **PUBLIC AWARENESS**

- promote oral health through community service and public relations -

We have partnered with Crest Oral B to donate thousands of small tubes of toothpaste and toothbrushes over the years. Last April, we donated 1,000 toothbrushes to the Presbyterian Church to aid those affected by natural disasters all over the country. During the pandemic, we donated hundreds of tubes of small toothpaste and some collected clothing to the homeless across Louisville. In September, thousands of tubes of toothpaste, along with toothbrushes were sent to Mission Clinics and orphanages in Kenya, Africa and given to needy families living with Sickle Cell Disease. These dental donations help over 370 children in Kenya who are in need of clothing, medicine, dental and other hygiene products.







#### 5 Year Retained & Nonrenew Trend




#### 5 Year Payment Status Trend
