- **5. EXECUTIVE SESSION.** The Executive Board moved into Executive Session for the purpose of discussing personnel matters.
- **6. REPORT OF THE PRESIDENT. Dr. Don Heine** gave the following report. Initial interviews for KDA Executive director position have been scheduled. Dr. Steve Robertson has stepped up as our temporary director and is doing a great job. Annual meeting is just around the corner.

7. **REPORT OF THE INTERIM EXECUTIVE DIRECTOR. Dr. Stephen Robertson** submitted the following report:

Kentucky Dental Association Interim Executive Director Report Stephen W Robertson, DMD

Legislative & Medicaid:

Our Legislative agenda remains intact. Assignment of Benefits, Medical Loss Ratio, Retro term Recoupments and Medicaid improvement head our list. We are planning on once again supporting a soda tax as a method of funding the needed financial increases in the Medicaid program.

It is expected Fluoride will remain a constant issue, and the Kentucky Dental Board will be reviewing and updating regs as it is time for this process. There is no intention of opening the Dental Practice Act currently. As you are all probably aware the previous Medicaid expansion regulations were struck down by the legislature. New regulations have been filed, and as before were found deficient in review. The Governor has overridden this, and we filed written comments on the May 31 deadline for public commentary. This is an ongoing process that will be closely monitored.

The Technical Advisory Committee for Dental Medicaid and the Medicaid Advisory Committee have asked for specific information regarding Dentist utilization numbers on multiple occasions. We are following the most recent requests to see if an open records request may be warranted.

We are amid the unwinding of the Medicaid Expansion population due to COVID. Kentucky has a plan in place which seems to be functioning well currently, as we have had minimal complaints. The plan is that all recipients of expansion benefits within the Medicaid program will continue to be enrolled through their slated renewal date. One month prior to their renewal date, they will receive a notification to attempt to reenroll or apply for other coverage through KYCONNECT. **As a reminder**, all Medicaid coverage for each patient should be verified on the day of the visit. There is an agreement that if you have verification on date of service, services will be covered as applicable. It is recommended you print the dated screen page or screen shot the page for your records.

Lastly, we have been notified by the State that a Pediatric Dentist needs to be nominated to the Childrens TAC by the KDA.

DEA Diversion CE requirement:

The Consolidated Appropriations Act of 2023, passed on December 29, 2022. Within this Act was the establishment of a one-time 8 hour continuing education requirement for renewal of DEA licensure. The required coursework is to cover the treatment and management of patients with opioid or other substance use disorders. This is slated to begin on June 27, 2023.

After significant research, the consensus is that the vast majority of Kentucky dentists have already met these criteria. The guidelines currently available state previous education is applicable, and that any Dentists within 5 years of graduation from an accredited dental school are exempt, as the information was covered within their education. Beyond the 5 years, if you have been through the last 3 licensure cycles in Kentucky, you were required to take 3 hours of KASPAR related CE. This would equal 9 hours, with a DEA requirement of 8. The small catch is that there is a very limited number of approved CE providers. The ADA, AMA, CERP, and AAOMS are included. Notably, AGD is not at this time, but that is being addressed and may take some time to correct. Many have taken their KASPAR courses through the Universities or CE Central at UK. All these courses would have fallen under the approved providers.

When it is time for each Dentist to renew their DEA licensure, all that will be necessary is to check a box stating the requirement has been met. No paperwork or information upload is indicated at that time. It is possible that there could be future spot audits where this information will need to be provided, but currently there is no mechanism for that to occur.

If you are concerned about hours, numerous courses are currently available or scheduled at both Universities that meet the specific criteria. Thes courses will also meet the HB1 KASPAR criteria, and any hours above and beyond the Kentucky 3 hour requirement will count toward the 30 hour renewal total.

The KDA office will be releasing a Constant Contact on this topic for members on Monday.

Kentucky Board of Dentistry:

I recently reached out to Jeff Allen, Executive Director of the Kentucky Board of Dentistry, and we had nice exchange of ideas. Jeff has agreed to participate in our KDA Executive Board meetings, and we also agreed to maintain an open dialogue.

We discussed Workforce issues, open licensure for Dentists and Hygienist (the Dentist and Dental Hygiene Compact,) and the SB94 APRN bill, which in Section 2.1c establishes a "Controlled Substances Prescribing Council." This Council is to have representation from many fields, including one General Dentist and one Oral Surgeon. The Board is open to recommendations from the KDA on these individuals.

ADA:

As most are aware, the ADA voted to change their Governance structure at the last Delegate meeting in Houston. As part of this Kentucky has been placed in a new multi-state region. We are currently establishing the Strategic Action Work Groups for this region and Kentucky was asked to nominate 4 individuals. The Work Groups are Direct to Dentists (products, services, and programs aimed at Dentists, Dental Students and teams across all practice modalities,) Tripartite (activities that directly support the operations of state and local associations,) and Professional/Public (initiatives to improve the oral health of the public and advance the profession of Dentistry.)

Our nominees are Jovita Devasia (UKCD,) Olivia Estes, Mark Graves and Gina Davis.

There are 2 upcoming ADA meetings in Chicago we have been asked to send representatives to attend.

The ADA Conference Week is combining several meetings including Executive Director and President Elect on

The ADA Wellness Summit on September 8, 2023.

These meetings involve travel fees only.

KDA Meeting:

I want to go on record stating how excited I am about the opportunities at the upcoming KDA Meeting! We have an excellent assortment of courses for the entire Dental team, so encourage everyone to bring the entire office and stay at the Galt House. These meetings hinge on filling our room blocks, so please stay on site, and tell others the same. The exhibit hall is nearing capacity, and there are numerous fun events planned. This is going to be a great one! Talk it up, get bodies to Louisville! We have done a fabulous job managing expenses, so we have a huge chance for a very prosperous meeting, with your support!

Closing:

It was recently announced that Kentucky came out on top of another list. In the America's Health Ranking Report on Seniors, it was reported our state was ranked #1 in senior extractions and 48th in overall health. Just more fuel for the fires in Frankfort!

More than likely this will be my only report as Interim Executive Director, and I want to take a moment to thank everyone for the opportunity to fill this role. It has been an honor! We have a fine Association with a dedicated staff, let them know you appreciate their efforts daily on our behalf! I have found out this is not a pert time job, but I'm loving it! Thanks again!

HB1001-State Budget Bill:

Indiana Medicaid is jointly funded by federal and state funds. The legislature recently passed HB1001 which funds Medicaid's request of \$12.9 million state share to be used for a dental investment with a total dental spend of \$47.3 million for the next biennial budget. Indiana Medicaid intends to review reimbursement rates every 4 years so this will eliminate long lapses in having fee increases. HB1001 also included funds for Indiana Medicaid to provide inflation rate increases for years when rates are not reviewed. Please stay tuned to IHCP Updates for more information. NEW TELEHEALTH GUIDANCE TEAM KENTUCKY. CABINET FOR HEALTH AND FAMILY SERVICES

New <u>telehealth guidance</u> from the Health and Human Services Office of Civil Rights (OCR) informs providers about post-Public Health Emergency expectations.

From May 12 to Aug. 9, 2023, providers will be given a transition window to ensure all telehealth platforms are Health Insurance Portability and Accountability Act (HIPAA) compliant. Beginning **Aug. 10, 2023**, providers will be subject to OCR penalties for non-compliance.

Please note: Platforms such as Apple FaceTime, Facebook Messenger video chat, Google Hangouts video, standard Zoom, or standard Skype are generally not HIPAA-compliant modalities for the provision of telehealth services. HHS provides a list of some vendors that represent that they have HIPAA-compliant video communication products and will agree to enter into a HIPAA Business Associates Agreement (BAA).
