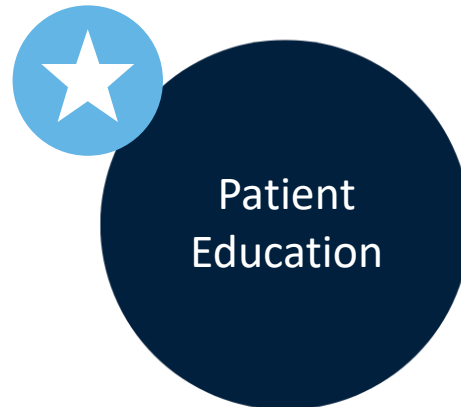

Qualifications for CHWs

- Be a legal United States resident
- Be employed as a community health worker in the state of Kentucky
- Be at least eighteen (18) years of age
- Meet and maintain the certification or recertification requirements

Services a CHW can provide





Health Navigation and Resource Coordination

- Find Medicaid providers to receive a covered service.
- Make an appointment for a Medicaid covered service.
- Arrange transportation to a medical appointment.
- Attend an appointment with the recipient for a covered service.
- Help a recipient find other relevant community resources such as support groups.

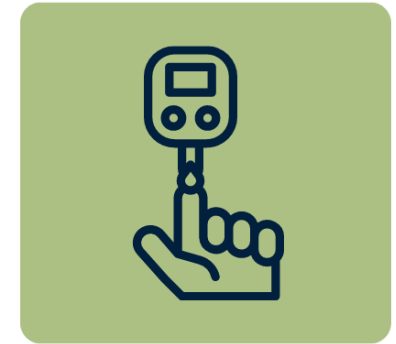

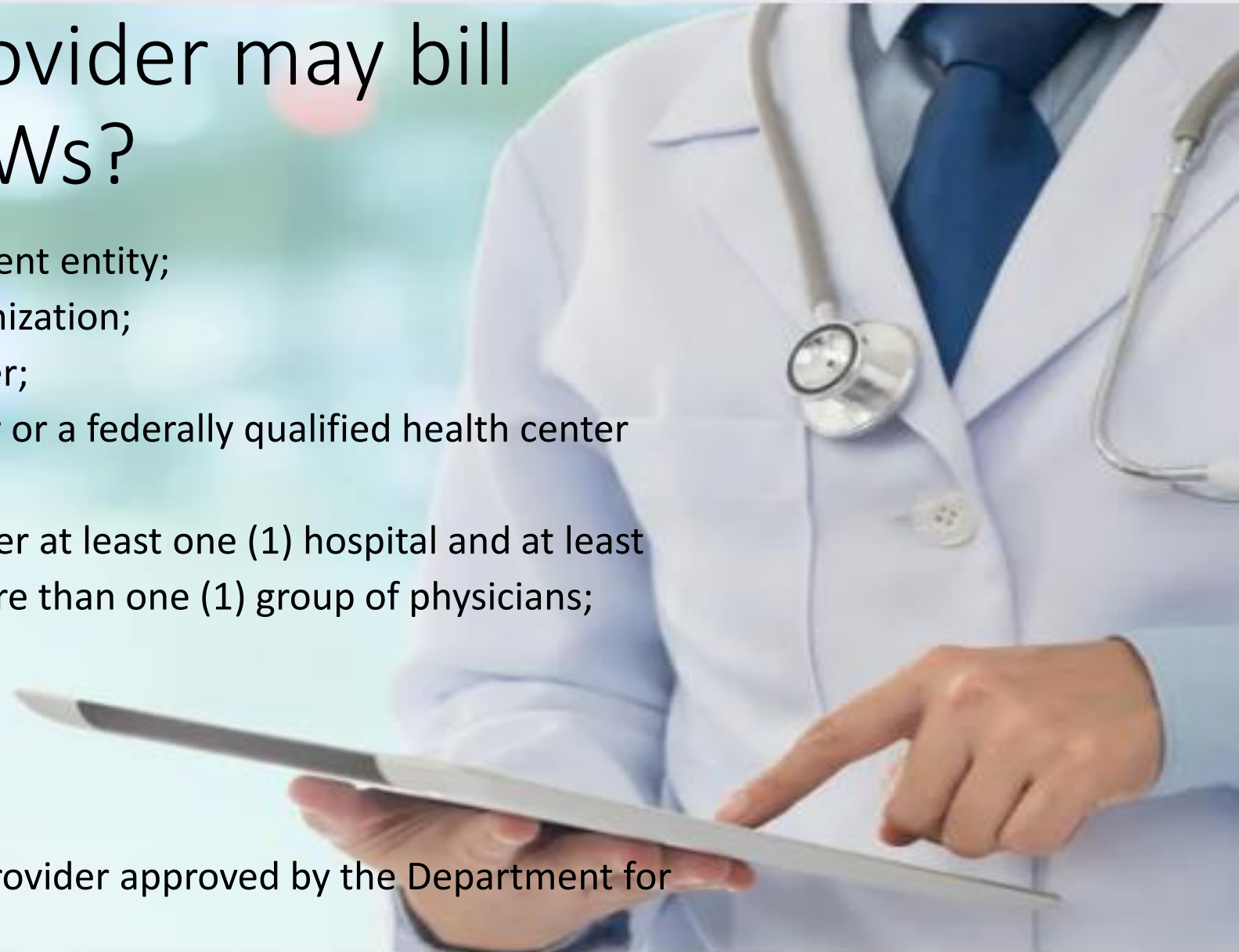
Health promotion and coaching

- Cessation of tobacco use.
- Reduction in the misuse of alcohol or drugs.
- Improvement in nutrition.
- Improvement of physical fitness.
- Family planning.
- Control of stress.
- Pregnancy and infant care, including prevention of fetal alcohol syndrome.



What Type of Provider may bill Medicaid for CHWs?

- An alcohol and other drug treatment entity;
- A behavioral health services organization;
- A community mental health center;
- A federally qualified health center or a federally qualified health center look-alike;
- A health system consisting of either at least one (1) hospital and at least one (1) group of physicians or more than one (1) group of physicians;
- A hospital;
- A local health department;
- A primary care clinic;
- A rural health clinic; or
- Another Medicaid participating provider approved by the Department for Medicaid Services.



Other Requirements for CHWs

Cannot enroll as independent Medicaid participating providers.

Must be related to a medical intervention outlined in individual's care plan.

There will be no reimbursement for a CHW that:

- Is paid by federal funds.
- Reimbursement is included in a per diem or cost settlement type payment.
- Is employed by a Managed Care organization (MCO).

CHWs are not eligible for WRAP payments.

CPT98960

- 1 Patient
- \$22.53 per 30-minute increment

CPT 98961

- 2-4 patients
- \$10.88 per patient, per 30-minute increment

CPT 98962

- 5-8 patients
- \$8.03 per patient, per 30-minute increment

MCOs will reimburse for CHWs and may hire their own CHWs



Fee-for-Service Medicaid will reimburse for CHWs
