- 2. INVOCATION. Dr. Andy Elliott gave the invocation.
- **3. APPROVAL OF MINUTES.** The minutes of the August 24, 2024, meeting of the Executive Board was approved.
- **4. BOARD ORIENTATION. Dr Samantha Shaver** presented a PowerPoint presentation concerning board orientation and general guidelines.

**NOTE:** All reports are presented in the minutes as they were submitted by their authors. No editing in the form of spelling or grammar has been attempted.

#### 5. REPORT OF THE PRESIDENT. Dr. Matt Milliner gave the following report.

While only 4 weeks have passed since my installation as KDA President, I have kept busy with various tasks. To this date, I have no dates set up for society visits, but have two requests and am working to determine best options for visits. I suspect a number of the visits will have to occur late this year or early in 2025 due to the timing of the component meetings typically on a Thursday or early in the week set against my own work schedule.

Dr. BJ Millay sent a message to Dr. Robertson and me a few weeks ago regarding the implementation of Medical Marijuana in Kentucky, effective January 1, 2025. Coincidentally, I had recently dealt with this in my own office and received recommendations from my attorney to update my handbook now to protect any hiring/firing issues after January 1. My attorney referred me to a lady who works for Dinsmore and Shohl, Ms. Lira Johnson for a possible webinar to offer to the KDA membership. She would provide background on the legislation and what it allows for with regards to employers and any decisions that may relate to medical marijuana in the future.

**ACTION ITEM**: I ask the Board to consider whether we want to coordinate a complimentary webinar with Ms. Johnson to educate our membership on the changes and potential issues we may encounter in our offices. She stated this is complimentary but suggested a \$500 donation to a dental charity from the KDA (or even the KDA Foundation).

The first journal article to KDA Today has been submitted and focuses primarily on the upcoming election and legislative priorities with a reminder at the end for all members to look at the new KDA/DentNet program as a member benefit. I am concerned we still struggle with our membership not acknowledging communications (email, US mailings, etc). Purchase recently met and several doctors had zero idea about this opportunity. The individual conversations were positive, and I expect the same with other members across the state.

I look forward to the upcoming legislative session and want to see the KDA prepare now for the work that officially starts in January. The Assignment of Benefits bill affects all dentists, regardless of location, practice modality, or area of focus within the profession. Patients and practices alike will benefit. We all have reason to organize now and begin seeking support for this bill in both chambers. Please consider organizing legislative meetings in your local component area. Inviting a house or senate member to a component meeting and allowing them to speak early in case they need to leave may be an option. Small groups of local members can also invite individual legislators to a local dental office to discuss AOB and any other pertinent dental issues.

As always, I appreciate the efforts of all Board members. Steven continues to work for the KDA and the profession. His efforts eclipse work personally observed in the last 10 years in the ED position, and I thank him for that.

6. **REPORT OF THE EXECUTIVE DIRECTOR. Dr. Stephen Robertson** submitted the following report:

### Kentucky Dental Association Executive Board Meeting Report of the Executive Director Saturday, October 5, 2024

I wish to notify the Board that I have been informed I need an extensive surgical procedure with the plan being to have this completed prior to the end of the year. This will not affect the day-to-day operations of the KDA office in any way. Plans are being made to cover scheduled events and legislative activities. It is assumed I will be available to communicate and consult on activities during most of the period I will be away from the office and will do my best conduct business as usual from the remote location of my home in Bowling Green and begin traveling to Louisville and other events as soon as clearance to do is provided.

This recent restructuring of the Council on Governmental Affairs now looms larger than ever, as this group, with other active, engaged members, will be the key to completing our legislative tasks ahead. We are continuing with our plan to garner numerous co-sponsors for AOB/NCS bill prior to the January legislative session. We will be posting this bill, through our sponsor, Sarge Pollock, in the first week of the session, prior to the long interim period. We are also continuing to push our Medicaid plan, even as new information continues to come to light. Current numbers for 2024, show Dental reimbursements through mid-August to be over \$200M. This is a significant increase over previous years, that the Department credits to the expansion of the adult benefits with no addition of funding to the program. There are also significant issues with DentaQuest who administers 2 MCOs within the Kentucky Medicaid system, while they as a company do have any contract with the State. In recent discussions with Department personnel, it has been indicated that the Department is recommitted to reengaging with the TAC to help drive forward positive change within the program. On this note, we have had significant turnover within the TAC. Recent new appointees include Kaitlyn Patel, Justin Kolasa, and BJ Millay. Returning members are Carol Braun and Joe Petrie. We currently do not have an active chair appointed, but Garth is continuing in his role on the MAC, and ready to assist in any way. Hopefully we are on the cusp of seeing quality cooperation to bring about real and necessary change. Additionally, we are aware that Fluoride will again be an issue this session. We must be organized and ready, as with recent court decisions the Fluoride opponents will be emboldened in their cause. I again would like to take a moment to recognize the activities of several entities that came together to help form a coalition to combat this issue last session, including many water companies, especially Louisville Water Company. Also, the involvement of Dr Kirby Hoetker, Dr Neil Rush, and Dr Julie McKee were invaluable. We are hoping to be able to avoid the topic of Mid-Level Providers, or Dental Therapists at this session, but we are at the whim of others. We continue to state we do not need to be inventing new team members that require additional time, training and funding when we have a critical shortage of existing team members in Dental hygiene and Dental Assisting and feel all efforts at this time should be focused on those issues. As many of you are aware, Murray State plans on opening a new Dental Hygiene in the coming year, and we have a meeting scheduled with Dr Ryan Quarles to discuss bringing appropriate Dental Hygiene and Dental Assisting programs back to the KCTCS curriculum.

Dr Laura Hancock and I recently attended the yearly Telehealth Summit, and I feel we are posed to see significant movement in this area in the coming year. While we have lost our one functioning program in the State, it has shown that the concept can work. We have a cooperative agreement among the 3 Dental Schools to establish a Teledentitry hub network within the schools, to provide both a training ground and safety net system for Kentucky. There were also great discussions on the Community Dental Health Care Worker program and establishing training pathways for current front office dental employees to get trained and certified to participate in this program. The Kentucky Board of Dentistry currently has new proposed regulations posted for public comment and we will be sharing comments. These regs were crafted almost a year ago, very early in the conversation and are heavily skewed towards Dental Hygienists filling this role. In a functioning dental office, Dental Hygienists do not have the time available to function within this this role. This position is already being performed by front office employees all over our state who consult on the phone with their patients on scheduling appointments, attending appointments, helping with referrals, scheduling transportation, assisting

with reimbursement issues, etc. This is the very job description of a Community Dental Health Worker. We need a pathway to get these folks certified so the appropriate Medicaid coding can be used for reimbursement. In early August, the KDA hosted Dr Ray Cohlmia, the Executive Director of the ADA, for faculty orientation events at both Dental Schools. I feel both events were well attended, and our goal is increasing the level of membership in organized dentistry within our educational system. We are lucky enough to have wonderful support from our three Deans, Dr Margaret Hill, Dr Jill Keaton, and Dr Jeff Okeson. Return events are being planned at both schools to push membership in the coming year, when both ADA and KDA dues will be at 50% for full-time faculty members. We will be consulting with the local components to work on getting the component dues reduced also.

The one action from my report is the KDA needs to fund the training course Dr Ansley Depp, our newly elected speaker is scheduled to attend in Indianapolis in February 7-9, 2025. The cost of the seminar is currently set at \$1300. This training will benefit both Dr Depp and the KDA moving forward. Dr Fred Howard, who will be assuming the role of 6<sup>th</sup> District Trustee in the coming weeks, will continue to be available to assist in this transition.

KDAP3 represents the very future of the KDA! We need to be promoting this program and encouraging participation at every possible encounter. This is literally a win-win-win program. It benefits the KDA, it benefits the dental offices better than any competing program on the market, and it has the ability to grow and offer more and more services and products. We need complete buy-in and participation from the Board, and for the Board to be actively promoting the program at home. On that note, there will be a discussion today led by Dr Samantha Shaver on the role of an Executive Board member. I remind you this is the decision-making body of the KDA when the House of Delegates is not in session, your attendance, participation, and execution of the tasks at hand are vital to both the present and future of this organization. In a recent meeting Dr Matt Milliner, our President attended, a state manager of dental supply company actually told Matt, he "would like to work with us to make the KDA relevant again." Let that comment sink in, deep. And hear it. Our complacency has dug us hole, we must work our way out. While I openly dispute the claim we are not relevant, the issue here is this individual and the dentist he is communicating with are not informed about the processes, functions and activities of the ADA and the KDA. This is not for lack of trying. We send out numerous emails, updates, Tidbits, Good Vibrations, bi-monthly Journals, full of current information. It is not being heard. We need answers on communications, sooner than later. We need to be communicating by text. At the meeting you will all, more than likely, have your phone laying on the table right beside you as you sit in this meeting. Ready to respond at its beckoning, we have all been trained. No one wants to receive a 3-page text, but we can alert people to other important communications they need to seek out and the response will be immediate. Vital Legislative alert was sent via email, please respond. Meeting scheduled on such date. Important update affecting Dentist in Kentucky. Notification of new podcasts being posted. It can work, we need to make it work. Never forget my infamous quote from last fall when a dentist in Eastern Kentucky told me, "I'm a busy ass Dentist, I don't have time to read that shit!" How then are we to inform, communicate? I recently attended the Pennyrile meeting in Bowling Green, the city where I practiced for over 30 years and was a very active member of the component. 16 members attended, 10 had no idea I had been Executive Director of the KDA for more than a year. 13 had never heard of KDAP3. We have sent numerous emails, it has been in every update that has gone out, and in at least 2 Journals, quite prominently. It is time to realize our message is not being heard. Part of your role as Executive Board member is to carry those messages. Please also always remember the actions of the Board are always unanimous, no matter the vote. If it passes by one vote or carries without opposition, we carry forward as one. There are no dissenting opinions was the votes are cast.

Getting back to the Component visit, invitation requests are out. We encourage you to reply with dates so we can get those meetings on the schedule for Matt and I. We are more than happy to come share the story of the KDA and the ADA and handle all questions. We have members throughout the wanting to be more active, more involved. We need to work together to identify these individuals and find roles for them at both the local and state levels. Several components are struggling to get going again, post-COVID. You are not alone with your issues. Be honest and ask for help, we will do our best to help get an event scheduled to get everyone back together in the spirit of congeniality that is the very backbone of the component experience!

We have a lot on our table, and busy times ahead, but, as always, **Together We Thrive!**



**Grants Awards:** 

- This past fiscal year we also submitted 9 new grant proposals.
- The college has reached the highest level of awards in the past 10 years, reaching 4.7M and 12 external awards in FY 2024.



#### Awards received this past year include:

- Dr. Marcia Rojas studying opioids treatment and oral health (\$1.356,469 from National Institutes of Health)
- Dr. Luciana Shaddox studying susceptibility patterns of periodontal disease in young individuals around the world (\$1.120,085, from National Institutes of Health)
- Dr. Octavio Gonzalez studying role of host responses in periodontal disease (\$494,532, from National Institutes of Health)
- Dr. Ian Boggero studying the role of telemedicine interventions to mitigate orofacial pain (\$131,298, from National Institutes of Health)
- Dr. Burt led the initiative from HRSA to continue to attend patients with HIV in our adult Dentistry Clinic (\$120,650).
- Dr. Singer oversaw the KY Cabinet for Health and Family Services block grant this year to aid in student loan repayment.
- Dr. Singer and Dr. Pam Stein assisted in an important surveillance of oral health in our state as well as service to our population (\$1,265,964).
- Dr. Santamaria was awarded an Internal IRC award of \$50,000 to study wound healing patterns post-periodontal surgical intervention.
- Dr. Miller was awarded \$98,369 from Delta Dental to study salivary biomarkers in periodontal disease.
- One internal grant, the Impact grant from the provost area (\$90,000) was awarded to Drs. Shaddox, Winfrey, and Miller to be used in an initiative to enhance multidisciplinary education and evidence-based clinical care in our school. We have included important modules of evidence-based practice in 1<sup>st</sup> year curriculum, enhanced mentoring opportunities for faculty and students, further enhanced rotations of students from other disciplines into our clinic (from Nursing, Social Work and Pharmacy) to enhance multidisciplinary approach to treat our patients. This grant includes renovating our facilities to include a

multidisciplinary learning classroom that will connect with monitors in different operatories of our wellness/DDKCRC clinics. This grant also enabled 11 pilot proposals to be awarded for junior investigators and students to participate in research.

#### **Research Events**

- The Annual Donald E. Knapp Memorial lecture series was presented at the Galt House in Louisville, KY in conjunction with the KDA meeting on August 21, 2024. Dr. Mauro Santamaria, UK faculty in Periodontics and Research, was the speaker, and he presented "Periodontal Plastic Surgery: evidence-based protocols to treat gingival recessions associated with non-carious cervical lesions." Dr. Knapp's son, Keith Knapp, awarded Dr. Santamaria with a certificate, making him a KY Colonel as a special thanks for his presentation.
- ADOCR Kentucky Fall symposium is taking place October 9, 2024, starting at 1pm in Spindletop, featuring the AADOCR president, Dr. Effie Ioannidou, as the keynote speaker and two UK speakers (Drs. # University of Louisville School of Dentistry (ULSD) Kentucky Dental Association Executive Board Report Meeting Date: October 5, 2024 Submitted: September 27, 2024

#### **Successful Reaccreditation**

During its August 8, 2024, meeting, the Commission on Dental Accreditation (CODA) granted the accreditation status of "approval without reporting requirements" for the UofL School of Dentistry's dental predoctoral education program, advanced dental education programs in endodontics, orthodontics and dentofacial orthopedics, pediatric dentistry, periodontics, prosthodontics, and allied dental education program in dental hygiene.

The status of "approval without reporting requirements" means these programs are approved to continue operations without additional monitoring/reevaluation from CODA and the next site visit will occur on the typical accreditation cycle. Our next scheduled site visit for these programs will take place in 2030.

#### **Student Activities**

- Our newest postgraduate residents and interns began their programs on July 1. We welcomed approximately 30 residents and interns across ULSD's seven advanced education programs General Practice Residency, Oral & Maxillofacial Surgery, Endodontics, Orthodontics, Pediatric Dentistry, Periodontics, and Prosthodontics including several DMD program graduates who chose to continue their education at the University of Louisville.
- First-year dental students arrived on campus August 1. The 120 members of the DMD class of 2028 came to us from 70 colleges and universities in 23 states. More than a quarter are Kentucky residents. All have earned at least a bachelor's degree and six have a master's degree. The average undergraduate GPA for class members is 3.67/4.00 and the average DAT is 20.
- The DMD class of 2028 received a special treat during their first full week on campus: a visit from Dr. Ray Cohlmia, Executive Director of the ADA and former Dean of the University of Oklahoma College of Dentistry. After meeting with Dr. Cohlmia, the students were energized and even more passionate about their chosen career. Dr. Cohlmia also spoke with ULSD faculty about a wide range of topics including access to care, evolving technology in dentistry, the dental school curriculum, and the cost of dental education. Our faculty deeply appreciated hearing his vision for the ADA and his insights on the profession as a whole.
- For the first time since the start of the COVID-19 pandemic, students participated in oral health screenings at the Kentucky State Fair this year. It was a great success, with 101 participants screened.

#### **Alumni Affairs & Continuing Education**

- Dr. Ann Windchy has been selected as the 2024 School of Dentistry Alumni Fellow. Dr. Windchy received her Bachelor of Science in Business Administration in 1967, her Master of Business Administration in 1971, and her Doctor of Dental Medicine in 1980, all from the University of Louisville. She completed a Residency in Prosthodontics in 1986, also at the University of Louisville. Dr. Windchy taught at the School of Dentistry from 1980 to 2013. During that time, she received several awards for exceptional teaching. Dr. Windchy is active in the local arts community and also provides free lectures and seminars to dentists and dental students on her YouTube channel.
- Danielle Brown started in August as the School of Dentistry's new Alumni Affairs & Continuing Education Coordinator.
- Megan Carbello has been selected as the Senior Director of Development for the School of Dentistry. This promotion reflects her significant growth as a leader and gift officer in her previous roles at UofL.
- DMD and dental hygiene alumni from all over the country returned to Louisville during the weekend of June 14-15, 2024, for ULSD reunion weekend celebrating class years ending in 4 and 9. We especially enjoyed getting to recognize and honor our Golden Alumni our 50th celebrants from the class of 1974.

- A great crowd also turned out for our Alumni and Friends Reception at the Galt House during the KDA Kentucky Meeting.
- The 2024 Dental Hygiene Legacy Symposium will take place Saturday, Oct. 12, at UofL's University Club. It will include the annual Floss Walk, a vendor product showcase, and CE/networking opportunities tailored specifically for dental hygienists.
- The 2024 Orthodontics Alumni Council Annual Meeting will take place Friday, Oct. 25 at the Fifth Third Club at Lynn Family Stadium. It will include CE presentations and a vendor showcase. Announcement of the Distinguished Alumni Award and Dr. Robert A. Escher Endowed Scholarship will take place during lunch.

#### **Research News**

- Dr. Fata Moradali's R01 grant application (1R01DE033702-01) has been approved for funding by NIH/NIDCR. The five-year grant will enable Dr. Moradali and his team to elucidate the structure and role of lipopolysaccharides (LPSs) produced by bacterial pathogens in the onset and progression of periodontal diseases. Commonly referred to as endotoxins, LPSs are potent immunostimulants that can provoke immune responses across various organs and contribute to numerous inflammatory conditions. This NIH-funded project will enable exploration of the mechanistic basis of these persistent adverse interactions at the molecular level and identify potential molecular targets for therapeutic development.

#### 9. REPORT OF UNIVERSITY OF PIKEVILLE.

## October 2024 College Updates:

- Recruitment of students and faculty are currently underway. Recruitment models have been developed in keeping with the mission of the TCDM to serve rural, underserved populations.
- Architects, engineers, and designers from EOP and Kahler Slater are developing the facility design for the Tanner College of Dental Medicine. The overall plan includes a five-story building housing ninetythree dental operatories, a simulation laboratory with sixty-five stations, classrooms, faculty offices, digital laboratories, central sterilization, and the Center for Research and Education in Technology (CRET) Innovation Center.

- A groundbreaking ceremony for the Tanner College of Dental Medicine is scheduled for October 4, 2024.
- The Commission on Dental Accreditation has completed its review of the application for Initial Accreditation of the Tanner College of Dental Medicine. A CODA Site Visit is scheduled for March 18 & 19, 2025.
- A 3+3 pathway to earn B.S. and D.M.D. degrees at UPIKE in six years is currently under development.
- The TCDM is collaborating with the Pike County Health Department on a grant supported by the Pallottine Foundation of Huntington which will assist in the provision of dental services to pediatric patients at the PCHD.
- On June 6, 2024, the University of Pikeville and Anthem Blue Cross/Blue Shield held a joint press conference to announce the launch of the Anthem Rural Dental Medicine Scholarships at the Tanner College of Dental Medicine. Recognizing the dire need for additional oral healthcare providers in rural Central Appalachia, Anthem Blue Cross/Blue Shielding has provided \$100,000.00 for multiple scholarships at the Tanner College of Dental Medicine.
