GREETINGS, ONE & ALL!

Greetings from Western Kentucky! I am excited to welcome everyone to the KDA Annual Session in August. This year brings a change in location. The Crowne Plaza Hotel, a sister property of the Galt House, will host our meeting and related events. Though not as sizable as the downtown venue, it will accommodate our members, families, staff, and anyone else you choose to bring. The recent updates maintained some of the most beautiful features in the meeting areas and ballrooms, created a new indoor/outdoor pool area for families to enjoy, and provided enhancements to the guest rooms and suites. The location is an easy drive to many areas of Louisville, including Jeff Ruby's, for those who have enjoyed an evening of fine dining for the last two years.

We begin the Annual Session with an evening reception in the Exhibit Hall. The 2025 courses provide a variety of options for each member. The long-heralded update on Bisphosphonates with Dr. Kushner returns on Friday along with the annual oral pathology update with Kushner, Scarfe, Shumway and Kande on Saturday. Dr. Jill Keaton, the inaugural Dean of the University of Pikeville, Tanner College of Dental Medicine, makes her debut at the Kentucky Dental Association, speaking on Non-Odontogenic Orofacial Pain. The meeting offers KASPER Updates with Dr. Becky Mercke, who received fantastic attendee feedback at the 2024 Annual Session. We also welcome the Past-President of the Kentucky Dental Hygiene Association, Mr. Adam Hall, who will speak on Saturday. The CPR recertification course also returns this year. For those accepting Medicaid, this year's course occurs on Saturday, with an updated format that will allow for open discussion of topics each dentist faces on a daily basis. Lunch is provided for this course.

Bring your best 70s wardrobe for Friday Night Fever with the band Velvet Crush! Hors d'oeuvres and a cash bar will be available. Everyone is invited to this FREE event. Tickets are available with preregistration or at the on-site registration desk.

Our meeting occurs concurrently with the Kentucky State Fair. 



There has been a new pathologic entity which was identified in the literature in 2003. Patients were found to have painful exposed bony areas of the jaws which occurred after simple dental procedures such as extractions. There were also reports of spontaneous exposures of bone in the jaws which were symptomatic. The common link was to the drug class of bisphosphonates. Bisphosphonates were given intravenously to cancer patients to combat the hypercalcemia often seen in multiple myeloma and metastatic cancers. This new condition was named osteonecrosis of the jaws (ONJ).

There are also oral forms of bisphosphonate drugs such as Fosamax, Actonel and Boniva. Although there is a higher incidence of osteonecrosis associated with IV administration of bisphosphonates, we have seen cases of ONJ associated with oral bisphosphonates that were prescribed to treat osteoporosis.

The lecture will review what we currently know about bisphosphonates, including recommendations for dental management and prevention of ONJ. We will also discuss what is uncertain at this early stage of the new pathologic entity.

Recent increases in research on oral and systemic connection have opened more doors and opportunities for oral health care providers to play a more active role in diagnosis and management of systemic conditions with oral manifestations. Dental professionals can play a very significant role in early diagnosis and management of some major systemic diseases. The first signs and symptoms of many diseases appear in the mouth and with a proactive

approach we can help with an early diagnosis. This will enable a timely start of treatment and can contribute to significant improvement in patients’ quality of life. In some rare cases it can prove to be life saving for patients.
