

**153rd KENTUCKY MEETING

1. **CALL TO ORDER.** Dr. Terry Norris called the meeting to order at 2:00 p.m.
2. **OFFICE OF PRESIDENT.** Dr. B. J. Moorhead was elected **President** of the Kentucky Dental Association during the 2013 Annual Session.
3. **ELECTION OF KDA SECOND VICE PRESIDENT.** Dr. Todd Cochran nominated **Dr. Dennis Price** from the Louisville Dental Society for the office of **Second Vice President** of the Kentucky Dental Association. Dr. Bruce Haskell seconded the nomination. Dr. Price was elected by acclamation.
4. **ELECTION OF ADA DELEGATES.** Dr. Ken Rich nominated **Dr. O. Andy Elliott** to fill the expired term of Dr. O. Andy Elliott as **ADA Delegate** for three years. Dr. Ansley Depp seconded the nomination. Dr. Elliott was elected by acclamation.

Dr. Mike Johnson nominated **Dr. H. Fred Howard** to fill the expired term of Dr. H. Fred Howard as **ADA Delegate** for three years. Dr. Andy Elliott seconded the nomination. Dr. Howard was elected by acclamation.

5. **ELECTION OF ADA ALTERNATE DELEGATE.** Dr. Mike Johnson nominated **Dr. Barry Curry** to fill the expired term of Dr. Barry Curry as **ADA Alternate Delegate** for three years. Dr. Fred Howard seconded the nomination. Dr. Curry was elected by acclamation.
6. **NEW BUSINESS.**

- Alternate Delegate to the ADA

Dr. Fred Howard is a duly elected delegate to the ADA. He is also serving as Speaker of the KDA House of Delegates. The Speaker of the House, by virtue of his office, serves as an alternate delegate to the ADA. Therefore, it is necessary to elect an alternate delegate to fill the vacated alternate delegate seat designated for the Speaker of the House.

MOTION: Dr. Bill Lee nominated **Dr. Ken Rich** to serve for one year as alternate delegate to the ADA. This fills the seat vacated by the current Speaker of the House which has a one-year term. The motion was seconded by Dr. David Narramore.

ACTION: ELECTED BY ACCLAMATION

- Social Media

Dr. Mike Johnson moved that a Work Group to address the subject of Social Media be established by the House of Delegates. The President of the Kentucky Dental Association is directed to take this motion to the next meeting of the KDA House of Delegates. Dr. Narramore seconded the motion.
