1. **CALL TO ORDER.** Dr. Fred Howard, Speaker, called the House of Delegates to order at 10:30 a.m.
2. **QUORUM STATEMENT.** Dr. Barry Curry announced that a quorum was present.
3. **INVOCATION.** Dr. Theodore E. Logan, Jr. gave the invocation.
4. **INTRODUCTIONS.** Dr. Fred Howard recognized past presidents in attendance.
5. **EXECUTIVE DIRECTOR'S REMARKS.** Mr. Michael Porter brought greetings from the KDA staff.

6. **COMMENTS BY THE PRESIDENT OF THE KDA.** Dr. Terry Norris gave a brief address to the House:
